#### Introduction:

The Initiative for Social Change ARSIS seeks to hire an expert to conduct training for 5 CSOs in part of the Sub-grating Application Schema. The sub-granting scheme falls under the second objective of the project that aims to finance 5 (five) initiatives that will promote Preventing and Countering Violent Extremism actions in five municipalities: Vlora, Fieri, Kavaja, Cerriku, and Pogradec.

The purpose of this assignment is to enhance the capacity of five grassroots Civil Society Organizations (CSOs) by providing high-quality training and technical support. The training will focus on improving their operational efficiency, advocacy strategies, financial management, and overall organizational development. This initiative aligns with the broader goals of the programme to empower local CSOs in sustainable governance and civil engagement. This project is implemented by the Initiative for Social Change ARSIS in partnership with ACPD and in collaboration with the Coordination Center against Violent Extremism and with the financial support of the Global Community Engagement and Resilience Fund (GCERF) program.

#### **About Initiative ARSIS**

The Initiative for Social Change ARSIS (Initiative ARSIS) is a non-profit organization established in February 2016. It is a non-governmental actor with influence in Albania's civil society sector. The mission of the Initiative ARSIS is to provide services and sustainable solutions to the most marginalized individuals and groups in Albanian society. The initiative ARSIS advocates and lobbies at local and central level on issues of child and youth protection, development and participation, improvement of socio-economic conditions of their families and strengthening the capacities of service providers, non-profit organizations, professionals and other actors working with children in vulnerable situations.

# About the project

The program aims to address the prevention of violent extremism (PVE) in six municipalities in Albania: Vlora, Fier, Kavajë, Cerrik, Pogradec, and Tirana, through a comprehensive and community-based approach. The focus is on supporting the CVE Center to enhance coordination and management of efforts related to violent extremism (VE) and reintegration and rehabilitation (R&R). This program seeks to build community resilience and promote social cohesion by raising awareness and developing the capacities of young people through civic education. It will also organize informational activities with parents, teachers, religious leaders, journalists, and local CSOs to promote democracy, the rule of law, and human rights. Additionally, it will provide psychosocial, educational, and well-being activities for returning children and their mothers in Tirana, facilitating their reintegration.

### **Duties and responsibilities of the expert:**

The expert will undertake the following duties and responsibilities:









- Conduct a needs assessment to tailor the training to the specific requirements of the CSOs.
- Develop a structured training curriculum that addresses key aspects of CSO development.
- Deliver interactive training sessions using participatory methodologies.
- Provide one-on-one or group coaching to CSO representatives as needed.
- Gather and incorporate feedback from participants to improve training effectiveness.
- Ensure all training materials are accessible and aligned with best practices in CSO capacity-building.
- Compile a comprehensive training report, summarizing key learnings, challenges, and recommendations for further CSO development.
- Maintain continuous communication with relevant stakeholders to ensure successful training implementation.

#### **Deliverables**

- 1. Develop a comprehensive training outline and materials before the training session.
- 2. Conduct two full days of interactive training for 5 CSOs.
- 3. Submit a final report, including key findings, feedback from participants, and recommendations for future support.

#### **Required Qualifications & Experience**

- Minimum of 5 years of experience in capacity building, training, and CSO development.
- Expertise in organizational management, advocacy, fundraising, and financial sustainability.
- Proven track record in conducting similar training workshops.
- Strong facilitation and communication skills.
